# European Hedgehog Erinaceus europaeus

### Background

Hedgehogs are a nocturnal species and one of our few, true hibernators. They are largely found in hedgerows, gardens and agricultural areas. Numbers are thought to be declining steadily, especially from their stronghold areas in Eastern England, although there are no accurate figures for population numbers.

Although hedgehogs are often seen killed on the side of roads, this is only one in a number of factors that is thought to contribute to their decline.



#### Status in Wales

Range:Widespread, found in all counties.Population:No accurate figures are available for Wales

#### **Threats**

(No threats have yet been reported for hedgehog as part of the BAP reporting, but these threats are commonly agreed)

- Increases in badger populations local effects
- Increases in road traffic density local effects
- Loss of habitat in the form of hedgerows and field margins
- Loss of habitat due to changes in gardening practices patios/decking, fences without gaps at the base and pesticide usage
- · Wounding from garden machinery such as strimmers

Issues affecting implementation

- 1. Lack of current distribution and status information
- 2. Lack of awareness by members of the public of the issues surrounding hedgehog decline
- 3. Insufficient liaison with gamekeepers

## Ecosystems approach and enhancing species resilience

There is a need to encourage the implementation of good practice to reduce hedgehog mortality and minimise the impacts of habitat fragmentation. Activity to support this would include:

• Connect with landowners via RSPB Futurescapes and WTs landscape-wide initiatives to ensure preferred habitats are restored/protected

- Gain support from fencing suppliers to encourage fences sold for private gardens are hedgehog-friendly
- Where high levels of road mortality occurs, consider road signs to warn drivers (similar to the ones for badgers) and create hedgehog culverts to aid safe crossing.
- Provide training and best practice guidance to encourage those undertaking woodland works to leave log piles and brash on site to provide hedgehog habitat
- Provide training and best practice guidance for those who carry out strimming activities in areas such as parks/amenity areas to encourage them to undertake checks for hedgehogs before undertaking work.
